COMPLAINT  
(RENEWAL)

Pursuant to N.C. Gen. Stat. §1-47, Plaintiff complaining of the Defendant, alleges and says:

1. Plaintiff is a North Carolina Hospital Authority operating several medical facilities in North Carolina pursuant to N.C.G.S. §131E-17 et seq.

2. Upon information and belief, Defendant Marcie Lynn Stafford is a natural person, citizen, and resident of Mecklenburg County, North Carolina, is not in military service and is not the dependent of a servicemember in active military duty.

3. Plaintiff obtained a Judgment against Defendant on October 19, 2012, in Mecklenburg County in the principal sum of Seven Thousand Eight Hundred Twenty-Four Dollars and 77/100 (\$7,824.77), plus interest at the legal rate from January 4, 2012, and costs, plus attorney's fees in the amount of Three Hundred Ninety-Six Dollars and 12/100 (\$396.12). A true copy of said Judgment is attached hereto as Exhibit "A".

4. There has been no payment on the account. The amount of Seven Thousand Eight Hundred Twenty-Four Dollars and 77/100 (\$7,824.77), plus interest at the legal rate from January 4, 2012, and costs, plus attorney's fees in the amount of Three Hundred Ninety-Six Dollars and 12/100 (\$396.12) is the outstanding balance on the account and is owed by Defendant Marcie Lynn Stafford. Account No. C1124402390, C1126902733

5. The Plaintiff has financial assistance programs available and the referenced account(s) have been screened and are NOT ELIGIBLE for such programs due to income disqualification, the presence of insurance coverage or no response from the Patient to previous inquiries. 1. Plaintiff have and recover of Defendant Marcie Lynn Stafford the sum of Seven Thousand Eight Hundred Twenty-Four Dollars and 77/100 (\$7,824.77), plus accrued interest at the legal rate from January 4, 2012, until paid in full;
2. Plaintiff have and recover of Defendant attorney's fees in the amount of Three Hundred Ninety-Six Dollars and 12/100 (\$396.12);
3. The costs of this action be taxed against Defendant;
4. This verified Complaint be used as an affidavit for any orders by the Court;
5. For such other and further relief as the Court deems proper and just.

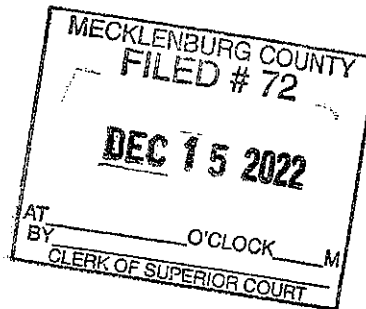
