Hi Lou,

Thank you so much for getting back to me. I am not entirely sure what "PRTF" is but I assume that it is the residential treatment. He was not there for that. He was there in the emergency care for suicidal ideation. The IVC was approved for 15 days, so I think that was the acute treatment. He was in "East 2" children's unit.

Also, I would like to ask if filing my complaint with you at DHHS includes a complaint with DHSR, as well as DRNC.

Ms. Glenda called me two days ago after receiving a complaint from a senator that I emailed. She was saying there were 3 different places to file a complaint and I just want to make sure I get the complaint filed everywhere it needs to be.

I also tried to get my son's records when I picked him up yesterday but they said they would mail them 30 days from now. I do know this is within HIPAA laws, but I do have concerns that records will be changed. (I am in contact with dozens of other parents whose children had been hospitalized there with loads of issues and they claim the records had been changed)

When I spoke to Dr. Brown on Wednesday, the 21st, she claimed that she had no idea that had been sexually harassed, despite me talking to all the staff about the issue, including his clinician. also complained to staff repeatedly.

Additionally, the nurse, and his clinician all denied any bruising to his face, however when I picked him up several days later, he did in fact have bruising. Minimal at that point but I am sure it was more prominent immediately after. The communication within the facility, as well as with me, was atrocious.

I believe I also have to file a complaint with the medical board concerning his doctor.
